**TENDER NOTICE**

On behalf of the Yanam Municipal Council sealed Item Rate tenders for the following work from contractors registered with the Public Works Department, Puducherry, Central Public Works Department, M.E.S., and other State Public Works Departments. Contractors other than registered in P.W.D., Puducherry should produce documentary evidence in support of their having satisfactory completed similar works as noted against each work in column no.(6) during the last seven years ending the last day of the month previous to the one in which the tenders are invited along with the application requesting the tender schedule.

Tenders will be received by the Commissioner, Yanam Municipality, Yanam as per the date and time mentioned above.

Tender forms and conditions of contract can be had from the office of the Commissioner, Yanam Municipality, Yanam on payment of Rs.1,000/- (Rupees one thousand only) plus VAT @ 4% by cash as cost of tender (non-refundable) for each work but, in case of tender schedule being downloaded, the cost of tender schedule is payable in the form of Demand draft in favour of the Commissioner, Yanam Municipality, Yanam and shall be enclosed in the envelope superscribing as "EMD/Cost of tender schedule" and on depositing the amount mentioned against the work in column no.4 as EMD in the form noted below.

The earnest money should be deposited by receipt of Treasury Challan/Deposit at call receipt of scheduled bank/Fixed deposit receipts of a Scheduled bank/Demand draft of a scheduled bank and submitted along with the application requesting the tender schedule. The earnest money should be drawn in favour of Commissioner, Yanam Municipality, Yanam.

Tender schedule can also be downloaded by the contractors from the website [www.yanam.nic.in](http://www.yanam.nic.in). But the contractors who had download the NIT from the website shall follow the procedures prescribed below.

1. The contractors who had down loaded the NIT from the website shall submit the tender schedule in two envelopes sealed in a single cover. The first envelope shall be placed with required amount of cost of tender schedule, EMD in the prescribed format drawn on or before the schedule date of receipt of applications and proof of documents on their eligibility as per the conditions of Tender Notice and the list of works on hand and the envelope shall be superscribed as "EMD/Cost of schedule" and the other envelope shall be superscribed as "TENDER SCHEDULE" wherein the duly filled NIT shall be placed and sealed.

2. The contractor who had purchased the tender schedule directly from the office shall also submit tender in two envelopes sealed in a single cover. The first envelope shall be placed with the copy of receipt of cost of tender schedule, proof of document for remittance of EMD while purchasing the tender schedule, copies of eligibility for having completed satisfactorily the required number of works and list of works on hand and the envelope shall be superscribed as "EMD/Cost of schedule" and in the other envelope superscribing as TENDER SCHEDULE wherein the duly filled NIT shall be placed and sealed.

3. On the scheduled date of opening, the tender schedules of the contractor who had down loaded the schedules/purchased the tender schedules from the office, the cover superscribing "EMD/Cost of schedule" shall be opened first and on fulfillment of furnishing the details of cost of tender schedule/payment of EMD/eligibilities/list of works on hand as mentioned above, only the other envelope superscribing as "Tender schedule" will be opened. The contractor's Envelope "Tender schedule" who do not satisfy the Tender Notice conditions will be returned unopened.

If the opening day of tender happens to be a public holiday, the same will be opened on the next working day.

The time allowed for carrying out the work will be **12 (twelve)** months including monsoon period from the tenth day after the date of written orders to commence the work.

The tender schedules will be issued only to the contractors for those who have obtained "TIN" (Tax Payer identification Number) registered with Deputy Commercial Tax Officer, Commercial Department, Government of Puducherry.

This work is covered under section 78 of Puducherry Value Added Tax Ordinance, 2007 and hence the contractor is liable to pay VAT at 2.8% of work done.

The Department reserves the right to reject any or all the tenders without assigning any reason there for.
