On behalf of the Yanam Municipal Council sealed Item Rate tenders are invited from eligible contractors noted in column 5 of the table below and registered with the Public Works Department, Puducherry in appropriate class for P.W.D. works in the Union Territory of Puducherry.

2. As per the instructions of the Superintending Engineer, Local Administration Department, Puducherry, Only Puducherry P.W.D. registered contractors are eligible for works costing upto 60 lakhs.

3. Tender forms and conditions of contract can be had from the office of the Commissioner, Yanam Municipality by submitting Earnest Money Deposit in the form of Demand Draft / Fixed Deposit Receipt of any Nationalized / Scheduled Bank for each work in favour of Commissioner, Yanam Municipality on the above mentioned dates on payment of Rs.500/- (Rupees five hundred only) plus Sales tax at the rate of 4% (Non-refundable).

4. The tender details can also be had by downloading from the website www.yanam.nic.in through NIC and the same can also be used for participation in the tender competition. In that case, the tender fee as mentioned in the para 3 above and EMD for each work should be paid by way of D.D. drawn in favour of Commissioner, Yanam Municipality and it should be enclosed along sealed cover.

5. The contractor should submit certificate along with copy of the upto date income tax return filed to the Income Tax Department.

6. A copy of the enlistment of contractor license issued by the Competent Authority should also be submitted (i.e.) Copy of Registration.

7. The contractor should submit a self-declaration showing the details of work on their hand along with their application requesting tender schedule and invariably the contractor should sign all the pages of tender schedule while submission.

8. The time allowed for carrying out the work as noted in column No.6 of the table above will be including monsoon period.

9. If the last date of issue of tenders scheduled/opening day of tenders happen to be Public Holidays the same will be issued/opened on next working day respectively.

10. The Commissioner reserves the right of rejecting any or all the tenders without assigning any reason thereof.

11. Contractor should produce TIN (Tax Identification Number) along with application to avoid delay in payments as per rule in force.

12. Contractors having pending works for more than three months after agreement period will not be considered for issuing of tender forms.
