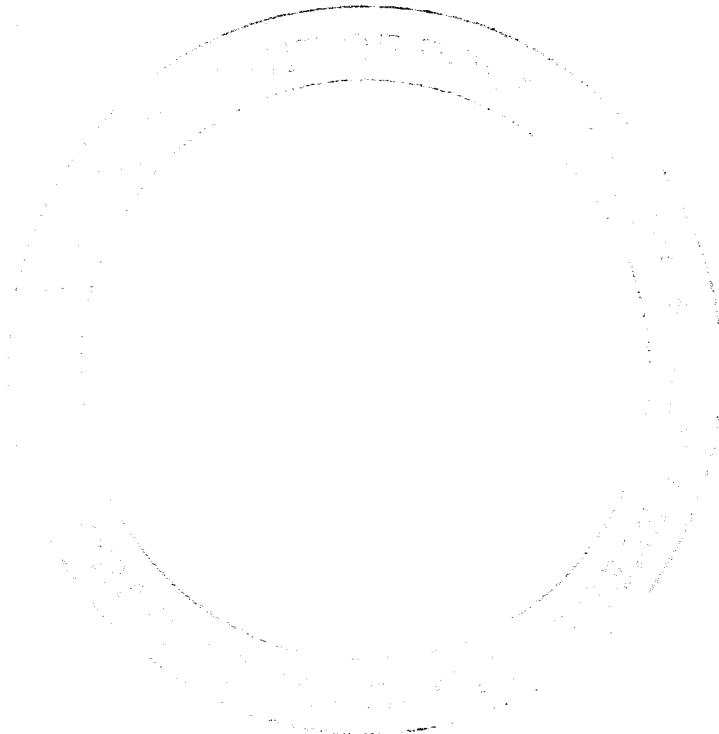

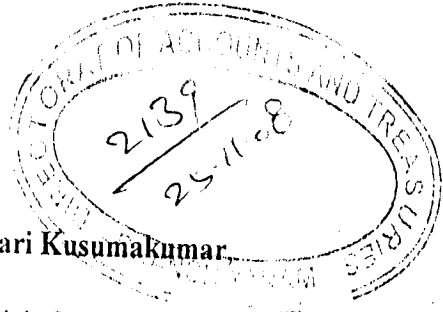

It is stated that Thiru. Badugu Eswara Rao, Statistical Computer now working as Public Relation Assistant in the O/o the Regional Administrator, Yanam, is continuing on deputation beyond the normal tenure of 3 years i.e. beyond 19.07.2007, without the approval of the Competent Authority. In view of his continuance on deputation for 5th year term i.e. beyond 19.07.2008, the approval of the Lieutenant Governor is required.

2. The Lieutenant Governor of Puducherry has issued clear instructions to allow officials on deputation beyond the normal tenure without prior approval of the Competent Authority and any lapse in this regard will be viewed very seriously. In the circumstances, the borrowing department viz. the Director of Information & Publicity and the Regional Administrator, Yanam, under whom the individual is working on deputation are directed to repatriate Thiru. Badugu Eswara Rao, without further delay as per the repatriation order issued by the Director of Economics & Statistics, Puducherry in order No. 5253/DLS/Estt/L1/007/09/845, dt. 3.10.2008. (copy enclosed)

3. The proposal for issuance of ex post facto orders for his deputation for 5th year term will be sent for approval of the Lieutenant Governor only after Thiru. Badugu Eswara Rao is repatriated and compliance report is sent to the department.
