With reference to the above, it is informed that the 3 numbers of applications in Form-1 dated 15.12.2006 submitted by you to the Public Information Officer, office of the Additional Secretary (Revenue), Department of Revenue and Disaster Management, Puducherry without remitting the necessary application fee was not acted upon since, the applications were treated as withdrawn.

Meanwhile, you have made complaints before the Central Information Commission, New Delhi under section 18 of the Right to Information Act, 2005. 3. *Your department permit/license no. and date of issue and validity period of permit for each bar and wine shop.*
4. *Supply a copy of permit or license of each bar and wine shop.*
5. *Address of stock godowns maintained by each bar and wine shop.*
6. *List of male and female employees working in each bar and wine shop as on 30.11.2006.*
7. *Daily sales timings of bars and wine shops.*
8. *List of bar and wine shops those has been granted permit/license to establish its sales shops at along the side of national highway road.*
9. *List of bar and wine shops those has been granted permit/license to establish its sales shops at very nearer (within distance specified in Pondicherry Excise Act) to temples and schools.*
10. *Monthly sales turnover of each bar and wine shops (period of information required - 01.04.2005 to 30.11.2006).*
11. *Monthly excise duty and countervailing duty paid by each bar and wine shop to the Purucherry Government (period of information required 01.04.2005 to 30.11.2006).*
12. *Supply a copy of Government approved price list of liquors those are in sales at Yanam region.*
13. *Is there any difference in price between PUducherry region and Yanam region to a same product of liquor. If yes please furnish the reason.*
14. *Is there compulsory weekly one holiday to employees of bar and wine shops as per Pondicherry Excise Act.*

17. Name and designation of officials who is responsible for inspection and supervision on Excise matter in Yanam region. Please furnish the copy of inspection report submitted by the Yanam Excise Authority to Excise Commissioner, Puducherry. (period of information required 01.04.2005 to 30.11.2006).

18. List of liquors if any seized and case booked by the authorized authority in Yanam region (period of information required 01.04.

19. Is there any penalty imposed to any license holder for his unlawful activities (period of information required 01.04.1995 to 30.11.2006).

20. List of permits transferred from one person to another person.

21. List of permits cancelled by your department.

In this connection, it is informed that you have requested above said information as on 30.11.2006. During the year 2006-07 there were 7 FL01 licenses and 7 FL02 licenses in Yanam region. As you have requested a copy of the said licenses vide item 4, you may deposit Rs.28/- @ Rs.2/- per page for 14 pages to obtain the same on any working day from this office. The said copies will contain information as sought/required by you vide item 1 to 3, 5 and 7 to 9.

The list of employees is not available in the office as the holders of licenses need not submit the same to this office under the Pondicherry Excise Act and Rules. (item 6).

There is no approved pricelist of liquors. (item 12).

No information pertaining is available in this office. (item 13).

You may go through the Pondicherry Excise Act. A copy of the Pondicherry Excise Act can be had from this office on payment of cost. (item 14).

(item 20).

For items 10, 11, 15, 16, 17, 18, 19, and 21 the particulars relating to each license holder, stock position, duty paid, permit issued to them are maintained in the separate files for every license holder.

The information has to be collected and consolidated from these files. However, as there is no use of such exercise for the administration, it would divert the resources of this office. As such it is decided to make you available all the concerned files so that you can collect the said information from the files available.

Therefore, you are informed to come and meet the undersigned with the list of convenient days to you so as to enable me to finalize a day. On that day all the connected office copies as mentioned above would be kept ready for your perusal. You may go through these records as available and collect the requested information. For this purpose no fee shall be charged for the first hour and a fee of Rs.5/- shall be charged for each subsequent hour (or fraction thereof).

## ANNEXURE-II

Vide second application, you have requested the following information.

1. Please furnish the details of Land Tax collected by your department in Yanam region from the residential, commercial, industrial and agricultural land owners along with the details of name and address of the land owner, size/area of the land, type of land, land tax fixed by the Govt. for each land owner and the actual amount paid by the land owner and the balance outstanding land tax from each land owner from 01.01.2000 to 15.12.2006.

2. Please furnish the lists of Government Paramboke lands available in Yanam region with the details of area, address of land location, survey/resurvey number/total size of the land, money value of the each paramboke land and details of occupation by any person if any as on 15.12.2006.

In respect of item no.1, I am to inform that the details of land taxes are maintained in the prescribed format of Land Revenue Demand Roll for every year which is also called as Land Tax Roll. The information was requested from 01.01.2000 to 15.12.2006. For this purpose there are separate registers for every year starting from 1999-2000 to 2006-07. Thus for total 8 years period 8 registers of A3 size are available. Each register contains approximately 50 pages. The information requested by you as is available is maintained in these records.

Therefore, you are informed to come and meet the undersigned with the list of convenient days to you so as to enable me to finalize a day. On that day all the connected office copies as mentioned above would be kept ready for your perusal. You may go through these records as available and collect the requested information. For this purpose no fee shall be charged for the first hour and a fee of Rs.5/- shall be charged for each subsequent hour (or fraction thereof).

Further, if you require any copy of the record you may make a request in writing so that necessary copies can be given on cost basis.

Or else, if you choose to have copies of all these records which may consist of approximately 400 pages, you may deposit Rs.2/- per page for obtaining the copies of the same.

In respect of item no.2, I am to inform that the entire settlement record of Yanam region has been converted into electronic form and hosted in the website <http://www.yanam.nic.in>. The settlement register is the basic document of description of land and its owners/occupier/enjoyer. In the said settlement register the first 9 columns would give the location of the land, block numbers, name of the owner, town survey numbers, resurvey numbers. Column 18 and 19 describe the extent. All the poramboke lands are indicated in columns 10 and 11.

You may download the same from the internet or collect the same either in soft or hard copy from this office on any working day by paying the copying charges.

**In this connection, it is reiterated that full and complete access to all the records pertaining to information sought by you as available in this office would be given to you. You may collect the details as desired by you from these records.**

As per Section 19 of the Right to Information Act, 2005, you may file an appeal to the First Appellate Authority of this office within 30 days of the issue of this order, whose particulars are given below:

1. Please furnish the list of persons those who were got free plot from your Department in Yanam region along with the details of names and address of the plot owner, plot no., size of the plot, money value of the plot, community/caste of the plot owner and annual income of the plot owner. Name and designation of the issuing authority of your Department from 01.01.1990 to 20.12.2006.

2. Please furnish the list of lands acquired in Yanam region by your department under Land Acquisition Act along with the details of name of the land owner, location of the land, total area of the land, amount paid to each land owner and purpose of land acquired from 01.01.1990 to 20.12.2006.

In respect of item no.1, I am to inform that the details of persons who were assigned free plot in Yanam region from 1976 have been consolidated and converted to electronic form with necessary and available details as far as possible and the same is hosted in the website <http://www.yanam.nic.in> maintained by the NIC centre, Yanam.

You may download the same from the internet or collect the same either in soft or hard copy from this office on any working day by paying the copying charges.

However, the details such as plot number, size of the plot has to be collected from the office copies of the patta. Such office copies are approximately 4000 in number with each copy containing four pages.

Therefore, you are informed to come and meet the undersigned with the list of convenient days to you so as to enable me to finalize a day. On that day all the connected office copies as mentioned above would be kept ready for your perusal. You may go through these records as available and collect the necessary information. For this purpose no fee shall be charged for the first hour and a fee of Rs.5/- shall be charged for each subsequent hour (or fraction thereof).

Further, if you require any copy of the record you may make a request in writing so that necessary copies can be given on cost basis.

Or else, if you choose to have copies of all these records which are approximately 16000 pages (4000 pattas x 4 pages each), you may deposit Rs.2/- per page for obtaining the copies of the same.

The information such as money value of the plot, community/caste of the plot owner and annual income of the plot owner will not be available in these office copies as well as in other records in this office. Therefore, this information as it is not available can not be furnished to you.

On that day all the connected records as mentioned above would be kept ready for your perusal. You may go through these records as available and collect the requested information. For this purpose no fee shall be charged for the first hour and a fee of Rs.5/- shall be charged for each subsequent hour (or fraction thereof).


