i) Tailoring & Embroidery.

Imparting training to the Rural Women in Cutting, Embroidery and Fabric painting.

Strength : 20 nos.

Duration : 1 year.

ii) Handicrafts.

Imparting training in various types of Handicrafts like Doll making, Pot painting, Wire bags manufacturing, Sand painting, Nib painting and Wool work etc.

Strength : 20 nos.

Duration : 1 year.

iii) Child Welfare:

Giving nutritious diet to the children.

Sanctioned strength : 50 children per working day.

Age limit. : 3 to 5 years.

Menu : Prescribed by the Commissioner of Labour, Puducherry.

Morning : Biscuits.

Afternoon : Lunch.

Evening : Egg (twice a week and Bengalgram whole for remaining 3 days). *per*

Expenditure : Rs. 5/- per child day.

iv) Child Labour:

Giving diet to the Child Labour.

Strength : No limit.

Age : Up to 14 years.
